(Part file), dated: 24.08.2015 of Health &amp; Family Welfare Department, Gandhinagar and thereafter the revised supplementary resolutions/circulars/guidelines issued by the State Government from time to time and the amendments/ additional resolutions/ circulars/ guidelines to be made by the State Government regarding medical treatments and medical benefits; shall be automatically implemented and applied to the employees/officers and pensioners of the State Agricultural Universities. This chapter shall be applicable from the date of issuance of Gujarat State Service (Medical Treatment) Rules, 2015.</p> <p>Provided further that the provision of the Rules which was in existence prior to the issuance of the Gujarat State Service (Medical Treatment) Rules, 2015 shall be applicable from the date of issuance of the COMMON STATUTE FOR AGRICULTURAL UNIVERSITIES OF GUJARAT (STATUTE NO.
