ANNEXURE-III (A)

Supplementary UG Academic Regulations for

Articulation Agreement

Rule -26.0 Renewal of Registration

26.3 Student enrolled under Articulation Agreement at partner University/Institution shall be required to register at partner University/Institution at the beginning of his/her respective semesters, in accordance with the university regulations. The student shall be required to produce evidence of the registration/enrollment at partner University/Institution to continue his/her registration at JAU failing which his /her registration will be cancelled.

Rule – 27. 0 Re-registration of the student

27.2 Student enrolled at partner University/Institution who wish to discontinue his/her studies due to exceptional and unavoidable circumstances can re-join JAU, Junagadh within 30 days of his/her partner University/Institution registration provided no disciplinary action has been taken against him/her during his/her time at partner University/Institution. After 30 days, he/she must follow the re-registration procedure according to JAU's common academic regulations for undergraduate degree. Such cases will be reviewed by the committee appointed by the Registrar of JAU, Junagadh. The re-registration of student who withdrew from the Articulation Agreement within stipulated time will be considered based on the committee's report.

Rule - 29.0 Continuation of Enrolled Student

(vi) Student enrolled under Articulation Agreement shall be required to produce evidence of the registration/enrollment at Partner University to continue his/her registration at JAU failing which his /her registration will be cancelled.

Rule – 30.0 Fees and Deposits

30.1 E. The fees outlined in sections B and C (Except C.10 & C.11) do not apply to students enrolled under Articulation Agreement.

Rule - 32 Academic Requirement

32.2. 2. Student enrolled under Articulation Agreement must complete requisite credits as per the courses mapped at partner University/Institution during fourth year to fulfil the requirement for the award of Degree which will be considered equivalent to Student READY Programme and or Courses offered in fourth year by the JAU.

* Course credits for students under Articulation Agreement will adhere to the academic regulations of Partner Universities/Institutes.

Rule – 38 The system of evaluation

Miller Sannia.

38.4 The evaluation method at partner University/Institution for a student enrolled under

Articulation Agreement will adhere to the academic regulations of partner

University/Institution and same will be considered at the JAU as per the courses mapped.

Rule – 39.0 Evaluation Responsibility

(f) For Articulation Agreement, each respective University/Institution will be responsible for evaluating the courses offered to the student by that University/Institution.

Rule - 42.0 Credits and Grade Point

42.12 Academic credits and corresponding grade points acquired by students enrolled under Articulation Agreement, will be transferred from partner university/Institution to JAU and duly recorded on the student's mark sheet/transcript as per the JAU norms and grade point will be derived as follow:

The grade point earnened by the students in subjects mapped against the course of JAU at partner university/Institution will be considered. If more than one course from the partner university/institution is mapped to a single course at JAU, the average grade point of all these subjects will be used. If a student fails to pass any subject in the mapping, they will be considered to have failed the corresponding JAU course. In this scenario, their grade point will be calculated as the average of all subjects or 49.00 percent, whichever is lower.

Rule – 45.0 Eligibility for Degree

(vii) He/she enrolled under Articulation Agreement has completed requisite credits as per the courses mapped at partner University/Institution to fulfil the requirement for the award of Degree.

The delegation of power for any amendments in the above regulations for Articulation Agreement will remain with the Vice-Chancellor, JAU, Junagadh based on the recommendation of the entitled committee and the decision of Vice-Chancellor will be final.
